#### **Academic Achievers**

Ta Saturday morning in January, academically talented sixth, seventh, and eighth grade students in the region took the ACT and/ or SAT college entrance exams, and the Explore exam, through the Northwestern University Midwest Talent Search (NUMATS). Based on the results of these tests, the West Suburban Consortium for Academic Excellence (WSCAE) recognized local students who scored over 500 on the SAT or over 20 on the ACT. The ACT tests reading, math, science and English skills, while the SAT tests writing, math and reading.

This year, WSCAE recognized 21 Gurrie Middle School students for outstanding achievement on the college exams - a record number.

WSCAE honored these students and others from the region at a special awards ceremony at Hinsdale South High School on May 6. The awardwinning Gurrie Jazz Ensemble played at the ceremony.

# Did you KNOW...

- Students, staff, and parents gave District 105 the highest overall state rating on the 2015-16 Illinois 5Essentials School Effectiveness Survey.
- The District 105 Early Childhood Program earned the highest Gold Star rating from the state for the 2015-16 school year.
- A team from the Gurrie STEM Club placed second in the Midwest Regional Remotely Operated Underwater Vehicle (ROV) Competition on April 25.
- Thirty former District 105 students received award scholarships at the LTHS Seniors Honors Day Assembly on May 22. Two former District 105 students received top Divisional and Departmental Honors.
- At its June 22 meeting, the Board of Education approved an extension of the Teachers' Contract through the 2017-18 school year. The contract includes annual salary increases and a bonus structure tied to student performance and to student and parent survey responses.

#### Anita Celli, Speech-Language Pathologist

Mrs. Celli worked in District 105 for 35 years, in every school except Spring Avenue. She spent most of her career in the district helping students at Seventh Avenue School. Mrs. Celli retired earlier in the year.

#### Patricia Langevin, Art Teacher

Mrs. Patricia Langevin taught art at Seventh Avenue, Hodgkins, and Ideal schools for 25 years. She was an educator for 35 years. Prior to working in District 105, she taught at Forest Psychiatric Hospital School and was a director at a residential school for students with conduct disorders.



"I have enjoyed teaching my wonderful students here in District 105," Mrs. Langevin stated. "I believe that art is one of the languages of the world. We live in a visual society; much of what we interact with and learn from must be decoded visually. Education in the arts builds students' confidence through perseverance and problem solving. I am very thankful to have had the opportunity to assist in the visual and creative development of District 105 students."



#### Laurene McHatton, Speech-Language Pathologist

For the past six years, Mrs. McHatton worked in the district, most recently serving Gurrie Middle School students, and earlier, students at Seventh Avenue and Spring Avenue schools. She was an educator for over 30 years.

"Having worked in other schools, I can truly state that District 105 is the finest in the area. All of the staff members are committed to helping students achieve their greatest potential. #### REGISTRATION for the 2015-2016 School Year

To make the registration process more convenient for families, the district is once again providing a mail-in registration option, which will also allow it to gain enrollment information earlier to improve school planning. Elementary students took this information home with their report cards, while kindergarten and seventh grade families received the information by mail.

For the second consecutive year, parents have the option to pay registration fees and load prepaid meal accounts online with a credit card. But parents still also have the option to pay registration fees and add funds to their students' meal accounts by check or cash.

The district will also provide a Walk-in Registration option on Tuesday, July 28, 4:00 -7:00 p.m., at Seventh Avenue School. More details were sent to parents.

The first day of school is Monday, August 24.

## Board of Education Election

At the Cook County Consolidated Election held on April 7, three District 105 Board of Education seats were up for election. Board of Education members serve a four-year term without pay, benefiting the community through their leadership of the district.

## **Rotary Club Honors PRINCIPAL**

### **District 105 YEAR END RESULTS**

District year-end achievement results were presented to the Board of Education at the board's June 22 meeting. Key findings from the presentation are provided below. The full presentation is available on the District 105 website <u>d105.net</u>.

- 71% of students achieved their annual math progress targets on the Measures of Academic Progress (MAP) testing. This result is above recent district trends.
- 62% of students achieved their annual reading progress targets on MAP.
- 64% of students scored above the fiftieth percentile on the spring math portion of MAP. This outcome is slightly above recent district trends.
- 63% of students scored above the fiftieth percentile on the spring reading portion of MAP. This percentage is slightly below recent district trends.
- 53% of 2015 Gurrie Middle School graduates registered for accelerated/honors math courses at LTHS. This is above recent district trends.
- 42% of 2015 Gurrie graduates registered for accelerated/honors LTHS English courses.
- 32% of 2015 Gurrie graduates registered for accelerated/honors LTHS science courses. This percentage is above recent district trends.



## Consortium of Educational Change (CEC) SCHOOL DISTRICT ASSESSMENT

A CEC Systems Assessment team of educators from high performing districts across the suburban area visited all five of our District 105 schools this year for two days to observe practices, examine evidence, and interview staff, administrators, parents, and students. Participation in the CEC Systems Assessment process reflects our district-wide commitments to:

- **■** Continuous improvement
- Labor-management collaboration
- A systems approach to organizational excellence
- The belief that all children can learn at high levels
- The measurement and reporting of our results.

The CEC team compiled a report at the end of the process to identify school strengths and opportunities for improvement based on the Baldrige Excellence Criteria and the practices and results of the highest performing schools. District-wide findings from the reports are highlighted below. The full district CEC report can be found on the district website, <u>d105.net</u>.

#### **Opportunities for Improvement:**

- The achievement gap persists for students who qualify for free and reduced lunch, have second language backgrounds, and receive special education services.
- There is a need to increase parent engagement in the learning process.
- The current state assessment system is undergoing change, which makes it difficult for the

district to have a clear path for a good assessment system.

#### Strengths:

- There is a strong, dedicated staff committed to continuous improvement and focused on student needs and requirements.
- Students and parents have a high regard for school personnel.
- There are decision-making structures in place to allow for data review so staff can monitor and track their performance aligned to key indicators and measures.
- There is a strong commitment to socialemotional learning.

## 1:1 Computer Program **EXPANDS** to Sixth Grade

T2013, the 1:1 Chromebooks laptop computer program began at Gurrie Middle School. The first year, students used the laptops in certain classes. The program was so successful that it expanded during the 2014-2015 school year to provide every Gurrie student with access to a Chromebook in most of their classrooms throughout the school day.

Chromebooks are laptop computers that run the Google cloud-based operating

Every Gurrie Middle School student had access to a laptop this past school year. In the fall, the program will expand to sixth grade.

system and web browser. They can only be used while connected to the Internet and only support web applications. They are lightweight, fast, secure, and very affordable.

A survey of Gurrie students showed that students who used Chromebooks were more engaged in their studies and more excited about learning. An increase in student engagement was seen in every category surveyed.

The 1:1 program is expanding to include sixth grade students in the fall.

"We are excited to be expanding our 1:1 initiative into sixth grade class-rooms district-wide next year," said Trish Murphy, the district's technology manager. "Based on the success of the 1:1 program at Gurrie, the program will expand to the elementary buildings, and it will be piloted in sixth grade. The devices will be available in all sixth grade classrooms at the start of the 2015-2016 school year. By selecting Chromebooks again

for the 1:1 initiative, students will have an easy-to-use device that starts up in as little as eight seconds and has a battery life that lasts the entire school day, which helps reduce technology barriers to learning. Similar to the Gurrie 1:1 program, the Chromebooks will be available all day, every day, in carts assigned to each of the sixth grade classrooms and will be integrated into all content areas. Leveraging these devices at Gurrie has increased engagement, collaboration and real world connections for our students. We anticipate realizing the same benefits with the sixth graders next year.

"The sixth grade staff will participate in professional development opportunities over the summer and throughout the next school year. These learning opportunities will focus on supporting staff with the 1:1 initiative, introducing new web-based tools, and exploring ways to deepen the implementation of tools such as Google Apps. Additionally, this initiative will increase access to technology district-wide and help all of our grade levels get closer to a 1:1 ratio."
